Forty years in environmental assessment, remediation, and risk management; thirty years in environmental dispute investigation and management, including cost containment, liability assessment, dispute resolution, settlement negotiations and expert witness services. Review and assessment of cost related to investigation and remediation of contaminated sites, including classification of costs incurred, projection of future costs and allocation of costs based on date, source and/or responsible party. Have reviewed and classified over \$10 billion in costs incurred for the investigation and remediation of contaminated sites nationwide, including over 1,000 former manufactured gas plants (MGPs). Consulting on major petroleum releases (including dilbit) from pipelines and train derailments. Management and oversight of remediation projects involving soil and ground-water contamination; remediation of chemical, petroleum, asbestos, and PCB contamination at factories, refineries, gas stations, hospitals, and commercial properties; performance of field activities, and selection/oversight of contractors. Many cases have involved the use of sophisticated spreadsheets to allocate costs to various time periods or to various sources.
