

## **REVISED PUBLIC NOTICE**

### **DRAFT SUPPLEMENTAL GUIDANCE: SCREENING AND EVALUATING VAPOR INTRUSION**

**Due to the COVID-19 public health emergency, the public comment is extended to June 1, 2020 and the original public information meetings scheduled for April 2020 are postponed until further notice. The Water Boards and DTSC are committed to protecting the health of the public and staff, and the uncertainty surrounding transmission of the novel COVID-19 virus and the known effects on vulnerable populations in our community warrants exercising extreme caution.**

The State Water Resources Control Board (State Water Board) and the Department of Toxic Substances Control (DTSC) released the Draft Supplemental Guidance: Screening and Evaluating Vapor Intrusion (Draft Guidance) for review and public comment on February 14, 2020. As stated above, the comment due date **is extended to 12:00 noon on June 1, 2020.**
