**NOTICE REGARDING SUSPENSION OF CONFIRMATION DEADLINES
AND CANCELLATION OF SCHEDULED CONFIRMATION HEARING**

PLEASE TAKE NOTICE that, on July 20, 2021, the United States Bankruptcy Court for the District of Delaware entered the *Order Adjourning Confirmation Hearing and Related Dates* [Docket No. 3845] (the “**Confirmation Scheduling Order**”)² with respect to confirmation of the *Ninth Amended Joint Chapter 11 Plan of Reorganization of Imerys Talc America, Inc. and Its Debtor Affiliates Under Chapter 11 of the Bankruptcy Code* (as subsequently amended, the “**Plan**”).

PLEASE TAKE FURTHER NOTICE that, the Confirmation Scheduling Order established dates and deadlines (collectively, the “**Confirmation Deadlines**”) related to confirmation of the Plan and scheduled the Confirmation Hearing for November 15, 16, 17, 19 and 22, 2021 (and additional days after November 22, 2021 as needed).
