Peter Kelso has been at the forefront of identifying emerging litigation trends for over fifteen years. Mr. Kelso specializes in developing strategies to quantify, estimate, and mitigate potential damages, and provides clients with expertise in product liability litigation, insurance coverage negotiations, mergers and acquisitions, liability ring fencing activities, and bankruptcy reorganizations. He has led and helped support numerous public policy initiatives to effectuate judicial and legislative reform at the state and federal levels.

Mr. Kelso has advised Fortune 100 companies, international insurers and reinsurers, and has consulted with many of the top investment firms on Wall Street on quantifying current and future potential costs associated with litigation outcomes. LRG was a third-party investment company that worked with companies, the insurance industry, and the financial community to help corporations effectively manage and diversify their litigation-based risk. LRG was the first company that worked to serve the US market with a focus on assuming defense-side litigation risks.

Mr. Kelso first began assessing the near and long-term valuation of asbestos claims and other mass tort litigation for global financial clients in the year 2000. He has advised many of the top investment firms on Wall Street regarding the legal and financial implications of companies facing liabilities associated with asbestos, lead, benzene, PFOA, diacetyl, silica, and pharmaceutical and medical devices. During this time, Mr. Kelso was the Senior Editor of the LexisNexis Mealey's Asbestos Liability Report and founded LexisNexis' Asbestos Bankruptcy Report and International Asbestos Liability Report. In addition, he created several other litigation reports and associated conferences, including the first Wall Street legal seminars, and utilized data aggregation and other data management services to advise clients on litigation risk. Mr. Kelso was principally involved in developing new legal products associated with mass tort, intellectual property, insurance, and other litigation.
